## IIA to respond to PCAOB proposal

THE PUBLIC COMPANY ACCOUNTING OVERSIGHT BOARD (PCAOB) has released for comment its proposed auditing standard titled "An Audit of Internal Control Over Financial Reporting Performed in Conjunction with An Audit of Financial Statements." (Release; [briefing paper](#).) If adopted, this document would be the standard for attestation engagements referred to in Sections 404 and 103 of the Sarbanes-Oxley Act. Comments on the proposed standard are due to PCAOB by November 21, 2003.
