Internal Audit Capability Model (IA-CM) for the Public Sector.

The *IA-CM* is a framework that identifies the fundamentals needed for effective internal auditing in government and the broader public sector. It serves as a universal model with comparability around principles, practices, and processes that can be applied globally to improve the effectiveness of internal auditing.

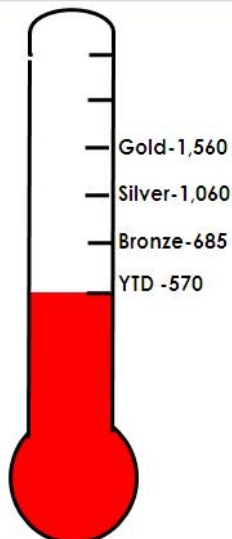

Speaker Profile: Patrick Bashore, Licensed Private Investigator

Pat Bashore brings nearly 30 years of experience working for the FBI. His assignments included eleven years in the FBI's New York Office where he investigated various types of fraud under the White Collar Crime Program. While assigned to the NYO, he also investigated cases of Public Corruption and Organized Crime. In the FBI's Louisville Office Pat's investigative assignments included white collar crimes, public corruption, drugs, fugitives and Foreign Counter Intelligence.

Pat was the Primary Relief Supervisor for White Collar Crime and Drug/Reactive squads, and served as the first Coordinator of the Louisville Office Fugitive Task Force. His duties further included the coordinator responsibilities for numerous FBI programs including the FBI National Academy; Crisis Negotiation Team; Media Relations; Police Training; and Special Agent Applicants.

While at the University of Kentucky Pat earned degrees in business administration and accounting. He received an MBA in finance from Fordham University, NY, NY. Pat is a former National Treasurer of the FBI Agents Association, and is an active member of the Society of Former Special Agents of the FBI. He presently serves as the treasurer of his fraternity's housing corporation at the University of Kentucky.

Speaker Profile: Jim Sniegocki, Licensed Private Investigator

Jim Sniegocki was employed by the FBI for over 30 years. He is an expert in the white collar crime area specializing in the investigation of financial crimes involving internal fraud, embezzlement, bribery, investment fraud, bankruptcy fraud and various other types of fraud. Jim served as a Special Agent in FBI Offices in San Antonio, TX; Monterey, CA; New York, NY; St. Louis, MO; and Louisville, KY. He has testified in Federal and local courts on numerous occasions and is qualified as an Expert Witness in complex financial matters.

In 1988 Jim founded and was President of Capital Intelligence Corporation, an investigative and security consulting firm. His work in the private sector included nationwide investigations for law firms and businesses involving internal theft and fraud, conflicts of interest, due diligence, witness location and interviews, litigation support and background matters. He has also conducted physical security reviews and consulted with companies on security matters.

Since 2005 Jim has been actively involved in personal investments, including real estate, stocks, commodities, options and new ventures. Jim earned his degree in accounting from George Washington University, Washington, D.C. He is an active member in the Society of Former Special Agents of the Federal Bureau of Investigation.
